Preparing for CAS EOY Interview

The EOY interview will be after your portfolio has been uploaded to Managebac and your Advisor has been notified. This is a mid-way check of your CAS experience, to assure that you have been meeting expectations, growing personally, and that you are on track to meet the CAS requirements to be eligible to receive the IB Diploma, next year. You should prepare notes in writing to address the following questions. Be prepared to come to the meeting and lead it. The purpose is to have an open and honest conversation with your Advisor. This is an ungraded element but is required as part of the CAS program.

1. What has been your most valuable / memorable / enlightening CAS experience so far, and why?
2. What skills have you now developed or sharpened most as a result of your experiences?
3. Which of your projects do you think will benefit you later in career, college or life and why?
4. What have you learned about working with others?
5. What has been a difficult / important ethical situation that has arisen from your experiences?
6. What are you finding to be the most difficult aspect of CAS and why?
7. CAS is often an experience of persistence and failure before success. How does this describe your experience?
8. What are your plans for the summer, that might be considered CAS? (Examples: organized sports programs, volunteer service work, planning meetings for current or upcoming long-term projects)
9. What questions or comments do you have for your advisor at this point?
10. Based on your engagement and documentation up to this point, your plans for CAS this summer, and your understanding of the CAS requirements,
 - a. What LO's have you not yet addressed?
 - b. When do you expect to complete the 18 months of the program with all LO's addressed in a meaningful way?
